

## **WHAT IS THE VISA APPLICATION PROCESS AND PROCESSING TIMES?**

### **1. Locate an EB-5 Project**

VisaConnect will make sure that you're connected with an EB-5 project that suits your individual needs. Available projects include USCIS-approved Regional Centers, as well as commercial enterprises.

### **2. Capital Investment**

After a project is chosen, capital must be invested. Current required capital amounts are USD 1,000,000, however, in certain areas, the required capital is USD 500,000. After the required capital is invested, VisaConnect will file an application with USCIS to have it registered. Oftentimes, clients must wait 24 months to hear back.

### **3. Conditional Residency**

Once conditional residency is granted, the EB-5 project must be managed for a period of two years. Depending on your individual needs, and the project chosen, employees may also need to be maintained. After the two-year residency period, VisaConnect will then file for permanent residency and you will receive your Green Card.

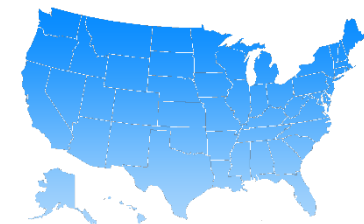

## **WHAT ARE THE FEATURES OF THE EB-5 VISA?**

This visa allows you to become a permanent resident of the United States after investing the required capital.

### **The main features of this visa are:**

- The investment must be verified and approved by USCIS.
- Investment must be proven by business registration records, documents identifying the source of money, or tax returns.
- Typically, you must remain in the United States for the duration of the two-year conditional residency. However, this requirement can often be relaxed.
- Amount of investment may be reduced depending on the project chosen.
