

## **EB-5 VISA APPLICATION PROCESS AND PROCESSING TIMES**

### **1. Locate an EB-5 Project**

VisaConnect and our partner US Immigration Attorneys will ensure that you're connected with an EB-5 project that suits your individual needs. Available projects include USCIS-approved Regional Centers, as well as commercial enterprises.

### **2. Capital Investment**

After a project is chosen, capital must be invested. Current required capital amount, since 15 March 2022 is USD \$900,000, in a Targeted Employment Area (TEA). After the required capital is invested, your US Attorney will file an application with USCIS to have it registered. Usually, clients must wait 24 months to hear back.

### **3. Conditional Residency**

Once conditional residency is granted, the EB-5 project must be managed for a period of two years. Depending on your individual needs, and the project chosen, employees may also need to be maintained. After the two-year residency period, your Attorney will then file for permanent residency, and you will receive your Green Card.

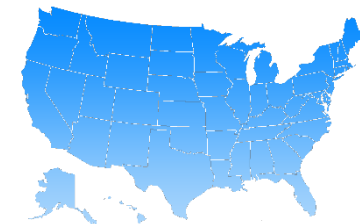

## EB-5 VISA FEATURES

---

This visa allows you to become a permanent resident of the United States after investing the required capital.

### The main features of this visa are:

- The investment must be verified and approved by USCIS.
- Investment must be proven by business registration records, documents identifying the source of money, or tax returns.
- Typically, you must remain in the United States for the duration of the two-year conditional residency. However, this requirement can often be relaxed.
- Amount of investment may be reduced depending on the project chosen. Projects in a Targeted Employment Area require an investment of **\$900,000 USD** whereas Project's in Non-Targeted Employment Area's require an investment of **\$1.050 million USD**.



## EB-5 VISA BENEFITS

---

- ✓ No age limit
- ✓ No English language requirement
- ✓ Minimal business experience needed
- ✓ In one EB-5 application, an EB-5 Investor, their Spouse and their unmarried children under the age of 21 years are all eligible
- ✓ Conditional Green Card typically acquired after two-year period, and can live in USA during conditional residency period
- ✓ Travel to U.S. without a Visa
- ✓ No Employment restrictions, and can set up a Business
- ✓ You may qualify for Social security and Medicare
- ✓ After 5 years residence in USA, you may be eligible for U.S. Citizenship & U.S. Passport.
