

## WHAT IS THE VISA APPLICATION PROCESS AND PROCESSING TIMES?

### A. Expression of Interest Application

- Provide information about your Business experience, Investment and Settlement funds.
- Expressions of Interest are selected every 2 weeks.

### B. Invitation to Apply for Residence

- If you score enough points, you are invited to apply for residence.
- You have 4 months to submit application and supporting documents.

### C. Approval to Transfer Funds and Make Investment

- Application Approved in Principle
- You have a 12-month period to transfer and invest your funds in New Zealand.

### D. Resident Visa with Conditions

- Resident visa granted, with travel conditions, must spend set time in NZ, and retain the investment.

### E. Permanent Resident Visa

- Permanent resident visa granted and conditions removed, at end of 4 year Investment period.
